# PRIVATE BARN – TRESPASSERS WILL BE PROSECUTED LOTRA MEMBERSHIP RULES GENERAL:

## The arena is now under security camera!!!

- 1. The Barn is for MEMBERS ONLY, other than for scheduled events. Members may sponsor a non-member. They must text Julie to let her know and gather the \$30 day money to get to Julie either before or directly after the riding occurs (Julie 349-1981). Make sure to ask your guest to clean up after themselves and their horses.
- 2. Members are strongly encouraged to get one sponsor for the Pioneer Day's Rodeo to help meet the \$7,000 added money goal. This is to be forwarded to the Board of Directors by February 1st.
- 3. Keep Board informed of updated contact information (e-mail, mailing address, phone number).
- 4. Heaters are only used for scheduled paid events and will be turned on by an authorized person.
- 5. Sprinklers should only be turned on by an authorized person.
- 6. Garage doors should be closed AT ALL TIMES.
- 7. Parents are solely responsible for children who should stay out of the area where there are horses.
- 8. All members will receive a membership card and should have it with them at all times to verify eligibility when asked. An updated membership list will be posted in the Office. It is the memberships' responsibility to question those they do not know, do not be offended if asked to produce your membership card.
- 9. Clean up your trash and clean up after your horse. A rake and wheel barrow will be available for this purpose.
- 10. Be courteous to others and share arena. Failure to do so can result in suspension of membership and ban from competitions.
- 11. Any complaints, ideas and/or suggestions must be submitted, preferably in writing and in detail, to the LOTRA Board to be accepted for discussion at a Board meeting. All complaints must be submitted in writing to any board member as soon as possible.
- 12. Each member is responsible for treating animals humanely (horses, cattle, etc.).
- 13. No parking in front of any door. Please be courteous of others entering the building.
- 14. 4-Wheelers are allowed to be used to pull roping training. Rules of sharing the arena still apply. This can be revisited by the board if it becomes a problem with the status of the ground.
- 15. All dogs must be on a leash.
- 16. NO glass bottles allowed.

- 17. Do not tie lead ropes tight to railing.
- 18. The schedule is as follows: Monday, Wednesday, Friday and Sunday (if no scheduled event) is for OPEN RIDING ONLY, NO CATTLE ALLOWED. Tuesday and Thursdays and Saturday (if no scheduled event) will be open for private cattle.
- 19. Make sure all lights are turned out when leaving the barn and all doors shut.
- 20. LOTRA cattle are for LOTRA sponsored uses only and may NOT be used for any reason by any member.
- 21. Absolutely no penning of personal cattle over 24 hours within the barn.
- 22. Penning of personal cattle and/or horses in outside pens over 24 hours must be approved by LOTRA.
- 23. LOTRA reserves the right to rent the facility at any time. The Secretary/Website Manager will be the scheduler unless the board appoints someone else. A one-week notice will be required for any entities to rent the barn so that the members will have adequate time to know the barn has been scheduled. Emergency use rentals may not have to have the one-week notice. LOTRA will email and/or text the members to let them know of the change and it will be posted on the lotra.org website and on lotrarodeo Facebook. Please get familiar with the LOTRA website and Facebook for notifications.
